Tasks:

- You will work closely with the Business Technology Domain Asset Chain's lead Business Technology Architect, your Delivery Lead, external Partners/ Suppliers and other teams to help design and/or continuously improve a modular, scalable and highly performing IT solutions that meet business needs and fit into the overall enterprise architecture standards.
- You will create an overview of the current situation, the future design for the solution and a clear path to realize this future design. In the process to realize this, you will collaborate with your stakeholders and ensure alignment inside and outside of your team(s).
- You need to communicate the designed architecture principles inside and outside of your team(s). If there are deviations, you will act upon this; and make sure that the design is realized.
- In our IT project/portfolio steering boards you will fulfill the role of a trusted advisor to ensure the right design choices are made based on considerations of business needs, current landscape, enterprise architecture principals, timelines and impact. Work closely with other BTO domains (platform teams / center of excellences / outsourced service partners) as well as internal functional departments like HR, Business Guidance and Procurement.
